





Introduction

There is a wide recognition of the contributions transnational communities make to the development of their countries of origin and destination. Diaspora engagement is a key component of national development strategies in many countries. Governments have designed and set up dedicated policies and institutional structures to achieve tighter bonds with their citizens abroad to enable them to contribute to local and national development.

While pursuing this goal, greater emphasis has been placed on the financial and economic contribution of diaspora to development via remittances or investment. There has been less focus on the potential of the diaspora for transferring knowledge and skills, as well as acting as bridge builders between cultures. These crucial dimensions remain on the margins of development policies but they are essential components for building joint prosperity through migration and contributing to the 2030 Sustainable Development Agenda. How to effectively and efficiently harness the human and professional capital of diaspora to contribute to a country's national and local development deserves more targeted attention.

This side event will bring together representatives of governments, civil society and diaspora leaders to discuss innovative approaches to engaging with the diaspora for social change. The event will be an informal discussion to exchange experiences and share best practice on effective partnerships to maximize the human and professional capital of diaspora for development at local, national and international levels.

It will be held within the framework of the Global Joint Programme on Mainstreaming Migration into National Development Strategies funded by the Swiss Agency for Development and Cooperation. The side event will be co-hosted by the Government of Kyrgyzstan (Ministry of Migration), the Government of Moldova (Bureau for Diaspora Relations), the Government of Morocco (Ministry in Charge of Moroccans Living Abroad and Migration Affairs and Ministry of Finance) and the Government of Serbia (Ministry of Youth and Sports). Diaspora representatives from Kyrgyzstan, Moldova, Morocco and Serbia will be associated with the event. It will also include UN representatives to showcase the contribution of global programmes and initiatives towards enhancing development outcomes of migration (the UN Joint Migration and Development Initiative and the Programme on Migration Mainstreaming in National Policies).

Proposed format

A 90-minute session followed by a moderated discussion.

- 1. How traditional forms and methods of engaging, empowering and enabling diaspora have changed in recent years? What are the new avenues for cooperation building on modern communication tools and social networks?
- 2. What are the practical examples and good practices set by countries of origin to partner with diaspora for development that could be replicated at local and national levels?
- 3. What could be the role of the international community to support governments in developing effective partnerships with diaspora? How can the potential of international cooperation be utilized?
- 4. What actionable recommendations could be included in the Global Compact for Safe, Orderly and Regular Migration to maximize the contribution of migrants and diaspora to development?

Additional activities in the margins of thematic session 4

- **1. iDiaspora forum stand:** an interactive stand to highlight the iDiaspora online forum. IOM will launch this formally with refreshments at a time TBC.
- **2.** A live discussion in the format of a World On The Move in cooperation with IOM Media and Communication Division, with a stand for taking interviews from the participants of the consultations. Questions for the interviews will be taken from the list of the questions for panel discussion.
